## **UPDATED RULEMAKING TOPICS**

The following chart reflects rulemaking topics discussed by the Board and incorporated into forthcoming draft regulations.

SECTION	DESCRIPTION
7002(e)	Insert language that a consumer can withdraw consent at any time.
7004	Include language that was previously held back to ease implementation and harmonize with Colorado regulations.
7013	Include language that was previously held back to ease implementation.
Article 3	Require businesses to include in their responses denying consumer requests information about where the consumer can submit a complaint.
Article 3	Include language harmonizing requirements for the different consumer rights.
7024(h)	Revise language to ensure that businesses provide consumers the opportunity to request all their personal information (not just 12 months of it).
7026	Insert language requiring businesses comply with the request to opt-out of sale/sharing in a time frame that is commensurate to the time frame it sells/shares it.
7027, 7050	Provide examples of "predict" and "detect" as exceptions for security incidents.
7028	Reinsert language regarding opting back in after having exercised request to limit.
7302(c)(1)	Clarify that an in-person hearing can be requested even when it is not a hearing open to the public.



## The following chart reflects potential future rulemaking topics that have been identified by Board members. They include topics discussed by the Board at prior Board meetings.

SECTION	DESCRIPTION
7001, 7002	Define processors and controllers
7002	Identify compatible purposes for which businesses can use personal information (i.e., exceptions to purpose limitations).
7003	Include a reading standard for disclosures and other provisions that make disclosures more accessible.
7003	Require specific disclosures (e.g., Notice at Collection) for mobile apps to be accessible in the app store prior to downloading.
7004, 7013	Address situations where consumers make a choice and then have difficulty withdrawing that choice. E.g., making a privacy selection (e.g., sharing address book) on accident and then not being able to find the choice again.
7015	Require the notice to opt-out of sale/sharing within mobile apps prior to or upon their use.
7022	Require businesses to allow consumers to selectively delete their personal information.
7027	Revise and/or add exceptions to the right to limit, including for HR/employee data, a prohibition on health-related research, and changes to the security incidents language.
Article 2	Provide model notices and other disclosures.
Article 4	Provide template or standard forms for service provider or contractor contracts.
Article 7	Provide additional guidance regarding financial incentive programs.
Voluntary Certification	Draft regulations to implement this option.
Business-to- Business Data	Draft regulations regarding this. Consider whether employment-related communications during employment falls within the "trade secret" exception.
Employee	Draft regulations regarding this. Consider whether any exceptions or

Access to Social Media API	Require social media companies to provide an API for consumers' agents.
