This rulemaking action adopts and amends regulations that further implement the California Consumer Protection Act (CCPA), commencing with Civil Code section 1798.100 et seg., to update existing CCPA regulations, specify requirements for businesses to conduct cybersecurity audits and risk assessments, specify consumers' rights to access and opt-out of businesses' use of automated decision-making technology, and specify when insurance companies must comply with the CCPA.

OAL approves this regulatory action pursuant to section 11349.3 of the Government Code. This regulatory action becomes effective on January 1, 2026.
